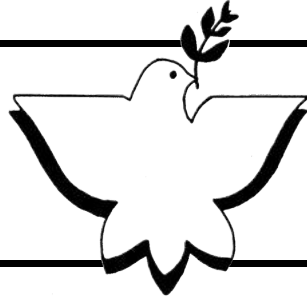

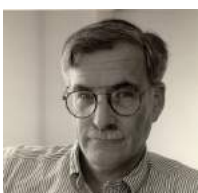

## INTRODUCING: THE PENNSYLVANIA NUCLEAR BAN ALLIANCE

There are 15,000 nuclear weapons in the world. Many of these are on hair-trigger alert. Sooner or later they will be used. Even one detonation would cause incalculable human suffering, probably 10-100 times worse even than Hiroshima. We can't let that happen. So, the Coalition for Peace Action and six Pennsylvania allies formed the Pennsylvania Nuclear Ban Alliance (PNBA) this summer. We are working with Peace-Prize winner ICAN, and with NuclearBan.US, in New England. With your help, we can help move the ball toward real de-nuclearization. It's starting to happen!

The US and the other nuclear nations will sign the new UN Nuclear Ban Treaty only once there is sufficient pressure on them to do so. As citizens, we call on our legislators to take steps to pull us back from the brink of nuclear war. We can also take other action:

- The 26 companies that profit from making nuclear weapons have major influence in Washington. Citizen boycotts, divestment campaigns, and bad publicity can persuade them. A national consumer boycott of General Electric already convinced them to move out of the nuclear weapons business.
- When the Administration announced its withdrawal from the Paris Climate Accords, cities, states, businesses, colleges, faith communities and individuals defiantly said: "We'll comply with the Accords anyway." That inspired us. We can get cities, states, organizations and individuals to comply - as far as they are able to - with the Nuclear Ban Treaty, too. We call this "Treaty Alignment."
- You can work towards Treaty Alignment as an individual, or get to work on your faith community, school or other connections you may have. Your personal and organizational commitment to boycott and divest from the 26 nuclear weapons companies can encourage local and state governments to do the same.
